Lincoln C. Chen

President, China Medical Board

Lincoln C. Chen is President of the China Medical Board. Started in 1914, the Board was endowed by John D. Rockefeller as an independent American foundation to advance health in China and Asia by strengthening medical education, research, and policies.

Dr. Chen was the founding director of the Harvard Global Equity Initiative (2001-2006), and in an earlier decade, the Taro Takemi Professor of International Health and Director of the University-wide Harvard Center for Population and Development Studies (1987-1996). In 1997-2001, Dr. Chen served as Executive Vice-President of the Rockefeller Foundation, and in 1973-1987, he represented the Ford Foundation in India and Bangladesh.

In 2008, Dr. Chen assumed the Chair of the Board of BRAC USA, having completed two terms as Chair of the Board of CARE/USA in 2007. He serves as Co-Chair of the Advisory Committee to the FXB Center on Health and Human Rights at Harvard. Dr. Chen also serves on the Board of the Social Science Research Council, the Institute of Metrics and Evaluation (University of Washington), the Public Health Foundation of India, and the UN Fund for International Partnership (counterpart to the UN Foundation). He was the Special Envoy of the WHO Director-General in Human Resources for Health (2004-2007), and the Founding Chair of the Global Health Workforce Alliance (2006-2008).

Dr. Chen is a member of the National Academy of Sciences' Institute of Medicine, the American Academy of Arts and Sciences, the World Academy of Arts and Sciences, and the Council on Foreign Relations. He graduated from Princeton University (BA), Harvard Medical School (MD), and the Johns Hopkins School of Hygiene and Public Health (MPH).

Scott Reeves ,PhD

Professor of Social and Behavioral Sciences

Director, Center for Innovation in Interprofessional Education, University of
California, San Francisco

Dr Scott Reeves is the founding director, Center for Innovation in Interprofessional Education and professor of Social and Behavioral Sciences at the University of California, San Francisco, USA. He is a social scientist who has been undertaking health professions education and health services research for nearly 20 years. To date, Dr Reeves has received over \$16m in grant capture from a range of funding bodies across the world. Currently his research work includes leading a \$2.1m grant from the Moore Foundation to understand the nature of collaboration in intensive care settings. He has over 350 national and international presentations (lectures, seminars, workshops) and has published over 200 peer-reviewed papers, numerous book chapters, textbooks, reports and monographs. His published work is widely cited, and many of his books and chapters have been translated from English to a number other languages including Japanese, Norwegian and Russian.

Dr Reeves is editor-in-chief, Journal of Interprofessional Care – the leading interprofessional journal in the world. He has also edited for other journals, including, the BMJ, BMC Medical Education and the Journal of Continuing Education for the Health Professions. Presently, he is working as a co-editor for a series of interprofessional textbooks exploring different elements of interprofessional education and practice for Radcliffe Press.

Originally from the UK, he spent six years at the University of Toronto developing conceptual, empirical and theoretical knowledge to inform the design and implementation of interprofessional education and practice activities. He currently holds honorary faculty positions in a number of institutions around the world, including, *Karolinska Institutet*, Sweden, the Li Ka Shing Knowledge Institute, Canada, and Queen Mary University of London, UK.

Dr Reeves has received a number of awards. In 2011, the National Health Sciences Student Association presented him with the Interprofessional Education Mentorship Award. He has also received the Ted Freedman Innovation in Education Award from the Ontario Hospital Association. In 2009, his Cochrane Review on interprofessional education also received an award for the most accessed Cochrane Review in the Effective Practice and Organization of Care Group.
